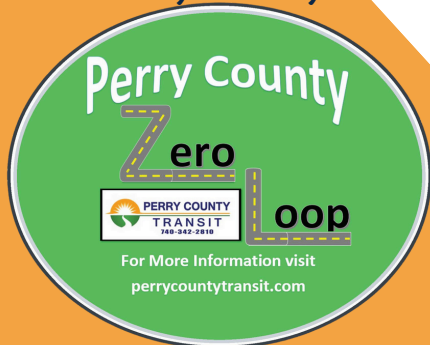


- Perry County Transit is located in the Village of New Lexington, Ohio and offers public curb-to-curb demand response shared ride (first come, first serve) transportation services

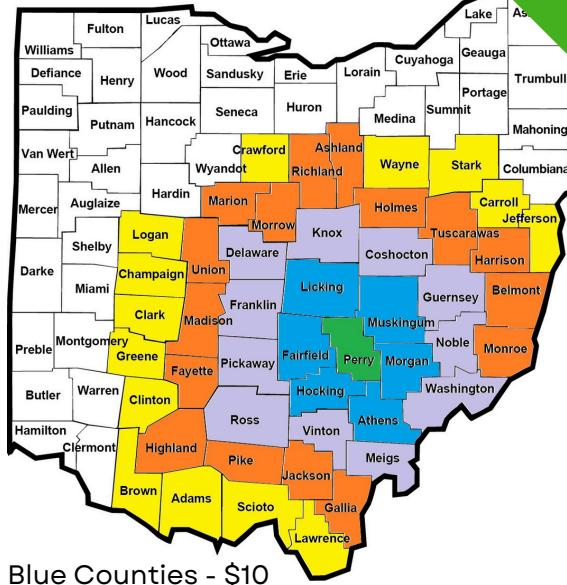

Schedule A Ride

To make a reservation, please provide your name, pick-up point, destination, time of trip, and a telephone number.

If you require the use of a mobility device or an attendant to travel with you please inform the reservationist when booking your trip.

A personal care attendant accompanying an Honored Citizen to their destination may ride free of charge. Service animals may board with their owner.

Bike rack vehicles are available, please inform your reservationist if you want to travel with your bike.

- Transit services may close for severe weather. Every attempt will be made to notify the passengers
- Seatbelts must be worn at all times, children must be in child seats as per law, to be supplied by the passenger.
- Children under 5 should not ride unsupervised.
- Remain seated at all times.
- No eating, drinking, smoking, or use of other nicotine products on the vehicle (including E-cigarettes and Vapes).
- Respect the driver and other passengers. Physical contact with a driver will not be tolerated.
- No weapons are permitted.
- No open containers of alcoholic beverages or illegal drugs are permitted.
- No flammable materials may be transported (exception for medical Oxygen)
- Shirt and shoes must be worn at all times
- Wheelchairs will be properly secured by the driver for the safety of all passengers.
- Perry County Transit will not go through a drive-thru. Each stop is considered a separate trip and will be charged.
- Drivers are not permitted to give change. Any additional funds will be added to your balance.
- Transit will arrive within a 30 minute window
- Drivers will wait no more than 5 minutes at the curb. Every attempt will be made to notify the passenger.
- Transit uses an automated calling system to remind passengers of their scheduled trips the night before and in route.
- Drivers are not permitted to enter a home.
- Cancellations must be made no less than one hour before the scheduled pickup window. Failure to do so will result in a No-Show.
- PCT reserves the right to deny service to passengers who continually cancel trips and are No-Shows.
